### **Kent and Medway Medical School**

Kent and Medway Medical School (KMMS) opened to our first cohort of students in September 2020 and achieved full GMC accreditation in 2025. Our vision is to become a beacon for first-class medical education and research and to attract the most talented aspiring doctors from within the local community and beyond, offering training and development opportunities that will help keep this talent in Kent and Medway. The five-year undergraduate programme is taught at the Canterbury campuses of both university partners with medical placements within Primary, Community and Secondary Care across Kent and Medway. KMMS brings together the existing centres of excellence in health and medical education provided by the University of Kent and Canterbury Christ Church University and local healthcare organisations, to offer a new model of person-centred medical education.

## Job purpose

KMMS Education Fellows contribute to the development and delivery of our undergraduate BM BS programme in a variety of settings, such as group tutorials, team-based learning, large group lectures, in the areas of assessment, anatomy and clinical skills, including communications skills and simulation. Education Fellows will also be expected to contribute to multi-station mini-interviews (MMIs), assessment work such as question writing, marking, standard setting, moderating and OSCE examination. Education Fellows are also expected to actively input on course development, programme evaluation and curriculum changes as is needed.

# **Key accountabilities**

- Undertake teaching activities of both undergraduate and postgraduate students, including providing support for student learning.
- Collaborate with colleagues in the school on course development, delivery and assessment, taking on appropriate administrative responsibilities.
- Support the quality assurance of teaching and assessment activities and other curriculum management aspects.

### **Key duties**

The principal duties and responsibilities of the successful candidate will include:

- Participate in the delivery of small and medium size group (workshops and seminars) and full cohort (lectures) including preparation, coordination and administration of teaching sessions.
- Deliver workshop and practical based teaching relating to clinical and professional skills including physical examination, communication and procedural skills.
- Supervise teaching sessions involving clinical simulation which includes modalities such as peer-to-peer examination, simulated manikins, procedural task trainers and simulated patients (actors).
- Provide effective feedback and debriefing to students relating to their clinical and professional skills development.
- Contribute to the creation, development and evaluation of course material for student- centred learning
- Ensure that the content, methods of delivery and learning materials will meet the defined student learning objectives.
- Prepare student and staff learning support materials.
- Reflect on own practice and the development of own teaching, learning and assessment skills.
- Plan and manage own teaching and tutorials as agreed with line manager.
- Contribute to the preparation, set-up, administration, marking and quality assurance of assessments including e-portfolio/ Objective Structured Practical Examination (OSPE) / Applied knowledge Tests (AKT) / Objective Structured Clinical Examinations (OSCE) and Case Based Discussions (CbD)

#### **Communication and teamwork**

- Use academic support skills to assist students in their learning and refer students as appropriate to services providing further help.
- Collaborate with academic and professional colleagues on course development and curriculum changes.
- Attend and contribute to subject group meetings and collaborative decision-making with colleagues on academic content, and on the assessment of students' work.
- Contribute to KMMS's annual multi-station mini-interviews (MMIs) as part of the student admission cycle.
- Contribute to OSCE examinations through examining and logistical activities.

#### **Continuous professional development**

- Possess sufficient breadth and/or depth of clinical knowledge in the discipline and develop skills in teaching methods and techniques.
- Engage in continuous professional development.
- Participate in regular meetings with their named supervisor or area lead.

Other duties, commensurate with the grading of the role, may also be assigned from time to time in line with the needs of the programme at different stages of its development and implementation.

- Ability to tutor students effectively and give clear and constructive feedback (I)
- Ability to work accurately and to tight deadlines, organising and deploying time effectively (I)
- Clear evidence of organisational, administrative and IT skills (i.e. Microsoft Office) (A, I)
- A commitment to contributing fully and flexibly to the full range of activities required (I)
- Firm commitment to achieving the University's vision and values, with a passion for a transformative student experience (I)
